



MUNICIPALITY OF GRASSLAND
SPECIAL SERVICES BY-LAW NO. 2025 - 02

BEING A BY-LAW OF THE MUNICIPALITY OF GRASSLAND TO ESTABLISH A RATE FOR CURBSIDE PICK UP RECYCLING SERVICES AS A SPECIAL SERVICE WITHIN THE TOWN OF HARTNEY, LUD OF ELGIN AND LUD OF MINTO FOR THE YEARS 2025 TO 2027, INCLUSIVE.

WHEREAS Section 312 of *The Municipal Act* of Manitoba, provides in part as follows:

312 If approved by by-law, a municipality may provide, as special service to all or part of a municipality, one or more of the following:

(e) Collection and transportation of waste or recyclable materials

AND WHEREAS subsection 320(1) of the Act provides as follows:

320(1) Subject to subsections (2) to (6) and subsection 321(4), a council may by by-law

- (a) Approve the local improvement or special services as set out in the plan or proposal; and
- (b) Authorize the municipality to impose taxes set out in the plan or proposal.

AND WHEREAS the Council of the Municipality of Grassland has prepared Special Service Plan No. 2025-02 to establish a rate for the provision of curbside pickup recycling services, as a special service pursuant to Part 10 of the Act;

AND WHEREAS the requirements as prescribed in sections 318, 319 and 320 of the Act have been complied with;

NOW THEREFORE the Council of the Municipality of Grassland in open council assembled enacts as follows:

1. **THAT** pursuant to subsection 320(1) of The Municipal Act, the Municipality of Grassland approves Special Service Plan No. 2025-02 attached hereto as Schedule "A".
2. **THAT** the Municipality of Grassland levy an annual special service tax upon all rateable properties, including taxable, grant-in-lieu and otherwise exempt property within the Municipality of Grassland as hereby attached in Schedule "B".

REPEAL

By-Law No. 2023-02 is hereby repealed.

SPECIAL SERVICE PLAN No. 2025-02

FOR

Establishing a rate for curbside pickup recycling services

(Pursuant of Section 314 of The Municipal Act)

(a) Description of Proposed Special Service

The Municipality of Grassland proposes to establish a special service tax for curbside pickup recycling services within the Town of Hartney, LUD of Elgin and LUD of Minto.

This special service tax will be shown on a separate line on all property tax statements and will be in place for the next 3 years (2025 – 2027).

(b) Special Service Area to be Levied

The Special Service Area to be levied under this proposal will be all taxable, grant-in lieu and otherwise exempt property within the Town of Hartney, LUD of Elgin and LUD of Minto described on Schedule “B” attached hereto.

(c) Estimated cost of the Special Service

The estimated cost of the recycling services for the next three years is as follows with an estimated 3% increase in costs between years:

(d) Method and Rate of Calculating the Special Service Tax

The method of calculating the annual Special Service Tax will be based on an amount per parcel. The rate structure is as follows
